Court Fees for SERVE FIRST Foundation Contributors:

Individual:

Individual defined as anyone between the ages of 19 and 64.

- **Tax Deductible Annual Contribution to the SERVE FIRST Foundation** for Sumter County Resident, Military (active or retired), member of the Sumter Tennis Association (STA) or member of a Palmetto Tennis Center USTA league team playing home matches at Palmetto Tennis Center is **\$500**. The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$5** per hour per contributor. No additional court usage fee for private lessons on clay courts. Each Individual Contributor will receive 3 Guest vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$5** per hour.
- **Tax Deductible Annual Contribution to the SERVE FIRST Foundation** for non-resident is **\$1000**. The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$10** per hour per contributor. No additional fee for private lessons on clay courts. Each Individual Contributor will receive 3 Guest vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$10** per hour.

Couple:

Couple is defined as two people who are married to each other.

The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$5** per hour per person. No additional fee for private lessons on clay courts. The Couple Contributor will receive a total of 3 Guest Vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$5** per hour.
- **Tax Deductible Annual Contribution to the SERVE FIRST Foundation** for non-resident is **\$1500**. The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$10** per hour per person. No additional fee for private lessons on clay courts. The Couple Contributor will receive a total of 3 Guest Vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$10** per hour.

Court Fees for SERVE FIRST Foundation Contributors

Family:

Family is defined as parents and their children.

- **Tax Deductible Annual Contribution to the SERVE FIRST Foundation** for Sumter County Resident, Military (active or retired), member of the Sumter Tennis Association (STA) or member of a Palmetto Tennis Center USTA league team playing home matches at Palmetto Tennis Center is **\$1000**. The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$5** per hour per person. No additional fee for private lessons on clay courts. Family Contributor will receive a total of 3 Guest Vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$5** per hour.
- **Tax Deductible Annual Contribution to the SERVE FIRST Foundation** for non-resident is **\$2000**. The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$10** per hour per person. No additional fee for private lessons on clay courts. Family Contributor will receive a total of 3 Guest Vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$10** per hour.

Super Senior:

Super Senior is defined as anyone 65 years of age or older

The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$2.50** per hour per contributor. No additional fee for private lessons on clay courts. The Super Senior Contributor will receive 1 Guest Vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$2.50** per hour.
- **Tax Deductible Annual Contribution to the SERVE FIRST Foundation** for non-resident is **\$500**. The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$5** per hour per contributor. No additional fee for private lessons on clay courts. Court Fees for SERVE FIRST Foundation Contributors

Junior:

Junior defined as anyone 18 years of age and younger.

- **Tax Deductible Annual Contribution to the SERVE FIRST Foundation** for Sumter County Resident, Military (active or retired), member of the Sumter Tennis Association (STA) or member of a Palmetto Tennis Center USTA league team playing home matches at Palmetto Tennis Center is **\$300**. The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$5** per hour per contributor. No additional fee for private lessons on clay courts. The Junior Contributor will receive 1 Guest Vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$5** per hour.
- **Tax Deductible Annual Contribution to the SERVE FIRST Foundation** for non-resident is **\$600**. The court rental fee for annual contributors to the SERVE FIRST Foundation is **\$10** per hour per contributor. No additional fee for private lessons on clay courts. The Junior Contributor will receive 1 Guest Vouchers annually. Each Guest Vouchers allow 1 guest to play for **\$10** per hour.

Court Fees:

- **Court Rental** (per use charge for one hour/per person) for a Sumter County resident, Military (Active or Retired), member of the Sumter Tennis Association, or member of a Palmetto Tennis Center USTA league team playing home matches at Palmetto Tennis Center is **\$20** per hour per person.
- **Super Senior Court Rental for adults 65 years or older** (per use charge for one hour/per person) for a Sumter County resident, Military (Active or Retired), member of the Sumter Tennis Association, or member of a Palmetto Tennis Center USTA league team playing home matches at Palmetto Tennis Center is **\$10** per hour per person.
- **Court Rental** (per use charge for one hour/per person) for a non-resident is **\$40** per hour per person.
- **Super Senior Court Rental for adults 65 years or older** (per use charge for one hour/per person) for a non-resident is **\$20** per hour per person.

Other Clay Court Fees:

Clay Court Fee for Private Lessons for Sumter County Resident, Military (active or retired), member of the Sumter Tennis Association (STA) or member of a Palmetto Tennis Center USTA league team playing home matches at Palmetto Tennis Center is as follows:

- **30-minute private lesson on clay** – additional **\$5** court fee in addition to private lesson fee
- **1-hour private lesson on clay** – additional **\$10** court fee in addition to private lesson fee
- **1 -1/2 hour private lesson on clay** – additional **\$15** court fee in addition to private lesson fee
- **2-hour private lesson on clay** – additional **\$20** court fee in addition to private lesson fee

Clay Court Fee for Private Lessons for non-resident is as follows:

- **30-minute private lesson on clay** – additional **\$10** court fee in addition to private lesson fee
- **1-hour private lesson on clay** – additional **\$20** court fee in addition to private lesson fee
- **1 -1/2 hour private lesson on clay** – additional **\$30** court fee in addition to private lesson fee
- **2-hour private lesson on clay** – additional **\$40** court fee in addition to private lesson fee

Clay Court Fee for Clinics for Sumter County Resident, Military (active or retired), member of the Sumter Tennis Association (STA) or member of a Palmetto Tennis Center USTA league team playing home matches at Palmetto Tennis Center is an additional **\$5** court fee in addition to the clinic fee.

Clay Court Fee for Clinics for non-resident is an additional **\$10** court fee in addition to the clinic fee.
